In your response in November 2013 to my PAIA request addressed to information officer Vedalankar the month before, you'll recall having (i) granted me access to LASA's records of the SAHRC's PAIA training workshop and PAIA audit, and (ii) certifying some non-existent records in your section 23 affidavit. (The rest of the records I requested, the majority, were refused on grounds now abandoned.)

With a view to simplifying things for you and lightening your task in gathering and providing me with all records specified in my consolidated list of requested records, I spent a couple of hours this morning auditing your November 2013 response, and deleting from my consolidated list, sent you on Friday the 12th as agreed, all record requests that have been disposed of to my satisfaction.
